This letter is to inform you of upcoming roadway construction for the Jackson Street Reconstruction project. Throughout the construction process, portions — if not all— of this roadway will be closed and possible detours set-up. Please see the attached map for the project location.

The contractor for this project is Veit & Company, Inc., 14000 Veit Place, Rogers, MN 55374, 763-428-2242 — the project management contact is John Hass.

- Roadway construction is expected to begin the week of July 5<sup>th</sup> and be completed for the 2016 season in November.
- On Tuesday, July 5<sup>th</sup>, Jackson Street will close from 7<sup>th</sup> Place to Kellogg Boulevard through the fall.
- The official detour route will be on Robert Street. Access to parking ramps will be maintained. I've provided a detour map for reference.
- Starting this Monday, June 27<sup>th</sup>, the contractor will be working with Saint Paul Regional Water Services to install temporary water services.
- Xcel Energy will continue their work on upgrading the electrical systems. This will be coordinated with the contractor. This utility work will require occasional lane restrictions on Jackson Street from 7<sup>th</sup> Place to 11<sup>th</sup> Street.
- Jackson Street from Kellogg Boulevard to Shepard Road will remain open until mid-July with some restrictions.

Jackson Street Reconstruction Project

- In mid-July Jackson Street from Kellogg Boulevard to Shepard Road will be fully closed for 6-to-8 weeks.
- Cross streets along Jackson Street will remain open to traffic with at least one lane of traffic in each direction. There may be some full closures at points during construction.
